STAKES Eight Belles S. presented by Kentucky Trailer Grade 2 - Thoroughbred

FOR FILLIES, THREE YEARS OLD. By subscription of \$200 each, which should accompany the nomination or by Supplementary Nomination of \$4,000 at time of entry. \$1,000 to pass the entry box; \$1,000 additional to start, with \$200,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% fifth. Weight: 123 lbs. Non-winners of a Grade I or II stakes in 2018, allowed 3 lbs.; \$60,000 in 2018, 5 lbs. The maximum number of starters for the Eight Belles will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners (in order I-II-III), then highest career earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Saturday, April 14, 2018 with 36 nominations.

MIA MISCHIEF disputed the pace off of the inside, edged clear entering the stretch, kept on well under stern urging and held sway. TALK VEUVE TO ME attended the pace in hand, commenced a bold bid four wide, was unable to best the determined winner, but continued on well to clearly prove the best of the rest. GAS STATION SUSHI settled four wide, swept into contention through the turn, loomed a danger entering the stretch, but flattened and settled for the minor award. SALT BAE contended toward the inside to the stretch, but lacked a response when called upon. CRIMINAL MISCHIEF was unhurried, came four wide and finished with a belated improvement. HOLD HER TIGHT was allowed to settle, came five wide but failed to make headway. AMY'S CHALLENGE contested the pace along the inside through the turn and dropped out.
