DIAVOLETTO was well placed and saved ground, angled off the rail in the stretch, closed determienly and edged clear late under right handed urging. SNEAK A COLD TREAT dueled early, shook clear on the turn, was hooked in mid stretch by the winner, held grudgingly and was second best. CANDY BITES was allowed to settle early, rallied in the stretch and angled out, closed willingly and held show. CLASSIC REWARD contended throughout while three wide, finished willingly but needed more late. LICENSE TO BLING dueled on the lead for a half, gradually weakened in the lane. URBAN RENEWAL was never far back, fanned out five wide in the upper stretch and lacked a late bid. I'LL TAKE JACKS unhurried early, improved his position while no threat. SIN AND REDEMPTION raced mid pack and was no menace. WILD BLING allowed to settle down the backside, failed to menace. FUZZY DEE JAY never far back while saving ground, had no rally. BEAU MEC was outrun.
