Footnotes

PRINCESS OF SYLMAR tracked the pace along the inside, got spirited up at the quarter pole, split foes at the three-sixteenths seizing a narrow advantage, drew clear under a drive through the final eighth being placed to a vigorous hand ride in the late stages. RUBY LIPS attended the pace from the two path, came under encouragement at the five-sixteenths, swung three wide for home, was in the midst of seizing command when the aforementioned rival split foes taking over, proved no match for that rival through the final eighth, came out with seventy yards to go impeding ASIYA causing that rival to clip heels and stumble, while holding for the place. ASIYA broke awkwardly at the start, settled three wide in close range of the front, came under encouragement at the three-eighths pole, swung four wide for home, kicked home mildly bidding for the place when impeded in the final seventy yards clipping heels and stumbling when RUBY LIPS came out in the late stages. COCONUT SHRIMP three wide towards the rear of a compact quintet, got asked at the five-sixteenths, swung three wide in upper stretch, bid mildly to the eighth pole before weakening in the late stages. BY GOLLY MOLLY stumbled at the start, was last and detached from the main body of the field early on, got asked three furlongs from home and offered no response. KISS THE LADY broke in at the start, was placed to a light hold showing the way along the inside of a compact quintet, came under urging at the five-sixteenths, cut the corner in the stretch, got displaced at the three-sixteenths, remained prominent to the eighth pole then gave way. There was a STEWARDS' INQUIRY focusing on the second place finisher RUBY LIPS in regards to coming out in the late stages on ASIYA, as a result RUBY LIPS was disqualified from second and placed third before the result was declared official.
