CITIZEN ADVOCATE pressed the pace outside of the leader, bid at the quarter pole and held sway under urging despite the rider losing the whip just inside the eighth pole. LAS MALVEGAS pressed the pace inside, bid three wide at the quarter pole, then couldn't match strides with the winner. BLUE FORTY bid belatedly between rivals. CUTE CADET rallied belatedly four wide. SUNSET QUEEN was impeded at the start, then steadied early, then rallied belatedly six wide. JAMRAA rallied belatedly inside. M. ANTOINETTE pressed the early pace four wide before giving way in the drive. GHOSTLY REFLECTION pressed the pace three wide to the stretch and then faded. LA CHIKY was clear early but gave way late. ALL THAT GLIMMERS was not a factor. LIMERICK LADY showed brief speed. CALIFORNIA GAL raced six wide.
