Footnotes

FOREWARNED chased the pace from the three path into the stretch, angled into the two path while engaging the leader at the furlong marker, dug in determinedly under a strong hand ride and proved best in the final strides. FUSAICHI'S WIND sprinted to the lead soon after the start, set a quick pace in the two path into the stretch, drifted in at the furlong marker and just missed hanging on along the rail. OVER ICCE settled three wide into the far turn, angled in to the rail at the top of the stretch, loomed boldly nearing the furlong marker, was shut off causing his rider to alter course to the three path then finished with good courage. MISSAP passed tiring rivals in the four path. MURRY SPUR steadied along the rail entering the clubhouse turn then failed to offer the needed response. DEER CREEK ROAD was outrun. MIDNIGHT MIKEY stalked the pace for a little over a half then gave way in the stretch. CHARLEE'S MAGIC had brief speed. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF OVER ICCE LODGED A CLAIM OF FOUL AGAINST THE RIDER OF FUSAICHI'S WIND FOR INTERFERENCE IN MID STRETCH. AFTER REVIEW THE STEWARDS DISQUALIFIED FISAICHI'S WIND AND PLACED HIM THIRD.
