STACHYS stalked the forced pace inside, had to wait behind a wall of horses on the final turn, swung out in late turn, finished full of run to take over passing the sixteenth pole, drew out. CHEROKEE'S GOAL stalked the forced pace between horses, advanced to take over inside in early stretch, gave his best to put away CHIEF COUNSEL before giving way to the winner. CHIEF COUNSEL pressed the slow pace outside, took over after passing the midpoint on the final turn, was headed in early stretch, couldn't get by his inside rival, tired late. KEY LARGO stalked outside, made a four-wide bid on the final turn, tired in the drive. MANKATO STRIKE stalked widest, tired. MR. MALABAR had outside speed under pressure, gave way after the midpoint on the final turn. KIND REGARDS forced the pace inside, gave way after the midpoint on the final turn, faded. The rider aboard MR. MALABAR lodged a claim of foul against the rider of CHEROKEE'S GOAL for interference late on the final turn. There was no change.
