### Footnotes

ISOLA PIU BELLA (CHI) raced to the outside near the middle of the field, responded to go after the leader on the final turn, took command in the stretch and drew off while kept to her task. RARE GIFT also raced off the rail near the middle of the field, came out a bit farther for the drive and rallied for the place but could not threaten the winner. GHOSTLY GATE raced close up inside from the start, continued along the rail to the stretch then lacked a winning late response. PERSONAL LEGEND hopped at the start, lacked speed off the rail then improved her position without threatening. FRIEL'S FOR REAL lacked speed three wide, came out four wide for the drive then lacked a rally. INJUSTICE set the pace from the inside but tired. UNINHIBITED SONG raced close up off the rail and gave way.
