PRIVATE TALE hopped at the break to be away last, settled back removed from the rail and well off of a contested pace, commenced a run leaving the three eighths pole, shifted in towards the rail entering the lane, continued his advance under strong handling in mid stretch, altered out in the vicinity of the sixteenth marker, closed determinedly and forged ahead in the final fifty yards. JAVERRRE , away alertly from the inside, was joined by EIGHTTOFASTTOCATCH leaving the seven eighths pole, duelled with that one through honest fractions, shook clear under urging into the lane, extended his margin in mid stretch, was confronted by the winner past the sixteenth pole and gave way grudgingly. ADIRONDACK KING saved ground within range, moved up under a strong ride leaving the far turn, angled out giving chase past the five sixteenths pole, ranged up four wide into the stretch, drifted out briefly before being straightened near the furlong pole then kept on with interest to close the gap. LAYERS , hung out five wide most of the way, edged closer approaching the stretch, gave willing pursuit to mid stretch then flattened out late. TIGER WALK settled four wide within striking distance, came under a ride leaving the far turn but lacked a serious response. HUGHES NEXT rated back early, saved ground and failed to menace. EIGHTTOFASTTOCATCH moved up two wide to engage JAVERRRE around the first turn, duelled outside that one for six and a half furlongs then weakened. PRETENSION , four wide early, angled in around the final turn and faded. NORMAN ASBJORNSON , well placed early off the rail, failed to respond after a half mile and faltered.
