WEIGHTS: 122 lbs. Non-winners of \$60,000 in 2019-2020 allowed 3 lbs.; \$40,000 at a mile or over in 2019 allowed 5 lbs.; \$25,000 at a mile or over since September 24, 2019 allowed 7 lbs. (Maiden and Claiming races not considered). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. (See reverse side for additional starting limitation information). Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Nominations closed Thursday, January 9, 2020 with 51 nominees.

PIONEER SPIRIT with the pace form the start, shook clear into the far turn, shook off a rival turning for home to be clear again in upper stretch, enough left to withstand the runner up in the final strides. BANKIT lacked early foot, encountered some traffic when advancing in the final turn, angled to the far outside for the drive, finished fast to miss. MOCITO ROJO in the second flight while off the inside, moved closer second turn and briefly lodged a mild bid outside the winner turning for home, failed to sustain that effort in the drive. M G WARRIOR with the early pace inside, took back before a quarter, saved ground through the final turn, went evenly in the drive. BRAVAZO settled off the pace and the inside, three wide into the lane, lacked a significant response in the drive. RATED R SUPERSTAR fell back to trail after the start, came four wide when attempting to rally, failed to stay on the final furlong. COLONELSDARKTEMPER settled off the pace and the inside, continued to race well off the pace, made little impact in the drive. SEVIER vied early outside the winner, began to give way in the far turn, continued to back up drive.
