DAISY DEVINE opened clear to dictate terms, widened entering the backstretch along the hedge, dug in to meet the bid of JULIE'S LOVE (GB) leaving the second turn, fought on through gamely and proved unyielding following a prolonged drive. The latter settled in hand, advanced between horses, moved up to engage the leader leaving the second turn, drew even and battled hard but was unable to best the determined winner. LAST FULL MEASURE attended the pace four wide, loomed a danger entering the stretch but was unable to bridge the gap. FUGITIVE ANGEL was allowed to settle, shifted out five wide leaving the second turn and finished with a mild rally. BIZZY CAROLINE contended along the inside, got through entering the stretch but lacked a response when called upon. REVELSTOKE tucked in along the hedge in mid pack, angled out with a quarter to run but went evenly through the drive. INDIAN POND was allowed to settle, came five wide but failed to respond. AFFAIR DABBLER was unhurried between horses and was never a factor. LA CLOCHE saved ground to no avail. Due to timer malfunction the race was hand timed.
