BOLD WORLD prompted the pace outside TYPHOON BERTIE, moved to take over midway of the turn and opened a clear lead, then was under steady pressure to prevail. PHARMSTAR chased the pace four wide into the stretch, then didn't do enough late while holding the place. SWEEP PRINCESS bumped and checked at the start, rallied along the inside to best the others. BLISSFUL KISS chased the pace three wide into the stretch and tired. BUCK FOR PAR failed to menace. TYPHOON BERTIE set the pace under pressure along the inside into the turn, then gave way. SWINGING GATE was no factor while racing four wide. LACY LADY raced in striking position into the turn and faltered. BE SILVER faded racing along the rail. STARBROW was never close after breaking poorly. REDOUBLED MISS bumped with SWEEP PRINCESS at the start, raced five wide on the turn, stopped and was eased late. The trainer of SWEEP PRINCESS lodged an objection against the rider of REDOUBLED MISS for alleged interference at the start. No action was taken.
