Plus an additional \$100,000 FTBOA to the owner of the winner if the horse is a registered Florida-bred registered with the FTBOA prior to becoming a two-year old, it must be a sire registered with the FTBOA standing in Florida when the foal was conceived. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$120,000, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to sixth. Supplemental nominations may at time of entry at a fee of \$10,000, which includes entry and starting fees. Weight: 122 lbs. Non-winners of a grade I stakes allowed, 2 lbs.; of a grade II or \$60,000 twice, 4 lbs.; of two races other than maiden or claiming, 6 lbs.; The field will be limited to 14 Starters, with Also Eligibles. Starters to be named through the entry box by the usual time of closing. If more than fourteen (14) entries pass the entry box preference will be given to graded stakes winners, then highest career earnings. Trophy to the winning owner. Nominations Closed Saturday, January 14, 2012 with 20 Nominations.
