BELIEVE IN CHARLIE rated off the pace, angled outside the leaders for the stretch run, then rallied to take over in early stretch and was all to prevail. ALLWEWANTFORXMAS reserved off the pace after breaking slowly, steadied to avoid running up on COR COR on the turn, angled out and rallied to prove second best while unable to get to the winner. MY DUE PROCESS allowed to settle, raced three wide around the turn and gained the show. QUEEN'S AWARD outrun early, passed tired rivals and just missed the show. RUNWAY READY away alertly, vied for the lead three wide into the stretch and tired. BOUNDING BI vied for the lead along the rail into the stretch, then faltered. FLOWER SPELL broke slowly, then was outrun while saving ground. COR COR vied for the lead between horses, then steadied from between rivals on the turn and faded.
