TWO YEAR OLDS. Free nomination by Sunday, November 27. \$500 to enter and \$250 to start. \$75,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a stakes race allowed 2 lbs.; two races other than maiden, claiming, or starter, 4 lbs.; a race other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by the usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings.

FACT FINDING held slight lead out of the chute then came under pressure from BASHA, continued to duel for the lead racing along inside of rival through the backstretch, edged away past the quarter pole, continued driving on top, pulled away then finished ridden out in final sixteenth. BASHA pressed in opening stages then dueled for the lead racing along the outside of FACT FINDING, could not match strides with rival leaving the quarter pole but continued in up close pursuit in upper stretch, was no match late for rival, kept along to secure place. SKINFLINT was allowed to settle in the run down the backstretch, saved ground along inside, shifted out brushing ARRECIFE midway through the turn, continued driving along the outside in the lane and gained position. MY FRIEND stalked the early pace along the outside, continued three deep leaving the backstretch, came under right handed urging four wide at head of the lane, raced in contention then flattened out. ARRECIFE raced in the back of the pack, picked up the pace leaving the backstretch, got brushed by SKINFLINT at five sixteenths, kept along outside in the lane. CAPITAINE stalked just off the inside in the backstretch, continued off top flight approaching the turn, urged few paths off inside at head of the lane, could not move on then faded. STORMING MY WAY was rated between rivals in early stages, hustled up along outside in the turn, came under right handed urging, angled in and failed to move on.
