WEIGHTS: 122 lbs. Non-winners of \$60,000 since September 27, 2023 allowed 3 lbs.; \$50,000 since September 27, 2023 allowed 5 lbs.; \$35,000 since August 27, 2023 allowed 7 lbs. (Maiden and Claiming races not considered in allowances). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. ALVA STARR broke on top, angled toward the inside, shook clear into the stretch, not threatened to the wire under steady handling. ROYAL SPA last to leave, lacked speed while off the inside, swung out to be five wide into the stretch, closed well to annex the place, not a threat to the winner. CONDENSATION forwardly placed while four wide up the backstretch and into the turn, fell back and angled in a bit through the turn, moved back out four wide into the stretch, outkicked for the second spot while edging clear of the others. LET'S BE CLEAR fell back to trail after the start, three to four wide into the stretch, displayed some mild interest well out in the strip to improve position. ADALINE JULIA in mid pack early, fell back through the turn in the two path, picked off a couple of tiring rivals while never a threat. CHANDANA remained back while saving ground to no avail,. MISS ARLINGTON prompted the pace while racing three wide for a half, gave way the final furlong. HIGH CLASS pressed the issue up front in the two path, backed up through the stretch. PER RULING #ECM2024-148 FROM HIWU, ROYAL SPA WAS DISQUALIFIED FROM SECOND TO UNPLACED DUE TO A POSITIVE TEST.
