STAKES Remington Springboard Mile S. Listed - Thoroughbred

FOR TWO-YEAR-OLDS. No nomination fee. \$2,000 to pass the entry box. Starters to pay \$2,000 additional with \$300,000 Guaranteed. Supplementary nominations may be made at time of entry for a fee of \$8,000, which qualifies to start. Weights: 121 lbs. First Preference to Stakes winning or stake-placed horses in graded/group stakes (in order I,II,III), then Preference to Lifetime Earnings. Lifetime Earnings will be determined according to statistics provided by Equibase. This race will be limited to twelve (12) starters. The guaranteed monies to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. The top three finishers in the Springboard Mile will get an automatic nomination to the Oklahoma Derby in 2025. The winner will receive an all fees paid entry into the Oklahoma Derby in 2025. Certain finishing positions in this race will earn points to qualify for the 2025 Kentucky Derby, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated. A suitable award will be presented to the winning owner.

COAL BATTLE taken back early and settled, inside, rallied on the far turn while two wide then moved out to be four wide in upper stretch, was under strong handled and was up in time. SPEED KING dueled for the lead while inside on the backstretch, was well handled then was in a long drive but was out finished in late stretch. DOMINANT SPIRIT was allowed to settled while inside on the backstretch, saved ground on the far turn and made a bid inside in the

stretch but was no menace to to top two. DR RUBEN M dueled for the lead while two wide on the backstretch, was in a long drive but weakened in late stretch. JOLLY SAMURAI was allowed to settled while three wide on the backstretch, moved out and made a bid five wide in the stretch but was no threat. BROOKLYN ALLEY CAT was unhurried early then made a mild rally while inside in the stretch but was no threat. MISTER OMAHA was allowed to settled while four wide on the backstretch, made a bid into the far turn but failed to menace in the stretch. KEENO was unhurried early and angled inside then was no threat. COMPLEX MUSIC chased the early pace while three wide on the backstretch, was used up then gave way. MEDICINE DOG was unhurried early then failed to menace. ESSAY was through after a half while inside and stopped. BLUE ANGEL was unhurried early while inside then stopped.
