COURT BATTLE led quickly, set a pressured pace, shook clear into the stretch and held sway, driving. FEDERAL LAW was off slowly, raced in mid pack, was hustled from the rail to three-wide late on the far turn then rallied outside. GEARHEAD stalked the pace, closed angling from the rail to four-wide late on the far turn then rallied gamely. GLENVILLE GARDENS was away slowly and settled in mid pack, came four to six-wide through the far turn and was all out in the stretch. WHERE'S THE WIDGET got away slowly and raced in mid pack, closed four and five-wide on the far turn then rallied between foes. ARTISTICO was off slowly, raced in mid pack, was hustled from two-wide and the rail on the far turn then rallied mildly. CARMENOOTZ forced the pace from the first turn, chased into the stretch but was left behind by the leader and evened out. NIGHT WATCHMAN, in range, dropped back a bit on the far turn and failed to menace. MIRACLE SILVER was off slowly, closed up and stalked four then three-wide on the first turn, chased two and three-wide on the far turn but couldn't sustain his drive and evened out in the stretch. LINE OF VISION raced from off the pace along the rail, altered course out from the rail

upper stretch but was not a threat.
